

The World of Cross Stitching issue 360 (July 2025) The Creative Craft Show competition

1. The Promoter is Our Media Limited (company number 05715415) a company incorporated in England and Wales whose registered address is at Eagle House, Colston Avenue, Bristol, BS1 4ST.
2. The promotion is open to all residents of mainland UK aged 18 years or older, except the Promoter's employees or contractors and anyone connected with the promotion or their direct family members.
3. The closing date for entries is 23:59 on 10 June 2025.
4. By entering the promotion, the participants agree:
 - a. to be bound by these terms and conditions; and
 - b. that should they win the promotion, their name and likeness may be used by the Promoter for pre-arranged promotional purposes.

9. The 11 winners' contact details will be sent to One Voice Media, organisers of The Creative Craft Show. They will email the tickets to the winners.
10. Transport and accommodation **are not included** and the tickets are valid for all days at the Farnborough event (4-6 March).
11. The winning entrants will be the first correct entry drawn at random from all the correct entries after the closing date. The Promoter's decision as to the winner is final and no correspondence relating to the promotion will be entered into. The Promoter may share the details of the winners with the prize provider for the purposes of fulfilling/delivering the prizes.
12. The winners will be notified within 28 days of the close of the promotion by post/telephone/email. If the winner cannot be contacted, or fails to respond within 28

days of such notification being sent, the Promoter reserves the right to offer the prize to a runner up, or to re-offer the prize in any future promotion.
