

The World of Cross Stitching issue 367 (January 2026) Mouseloft competition

1. The Promoter is Our Media Limited (company number 05715415) a company incorporated in England and Wales whose registered address is at Eagle House, Colston Avenue, Bristol, BS1 4ST.
2. The promotion is open to all residents of mainland UK aged 18 years or older, except the Promoter's employees or contractors and anyone connected with the promotion or their direct family members.
3. The closing date for entries is 23:59 on 29 December 2025.
4. By entering the promotion, the participants agree:
 - a. to be bound by these terms and conditions; and
 - b. that should they win the promotion, their name and likeness may be used by the Promoter for pre-arranged promotional purposes.
5. Entrants should enter by submitting their name and email address on the competition hosted on Gathered.how and agreeing to these terms and conditions. Entries received after the closing date of the promotion will not be considered.
6. Entrants must supply to Our Media Limited their name and email address as personal data is required for us to run the competition, choose winner(s) and arrange for the prize to be sent to the winner(s). 7. Only one entry will be permitted per person, regardless of method of entry. Bulk entries made by third parties will not be permitted.

9. The 11 winners will receive an email from *The World of Cross Stitching* asking for their postal address (for the purpose of posting the prize only). *The World of Cross Stitching* will then post the kit bundles once all winners have replied on behalf of Mouseloft.

The Promoter may share the details of the winners with the prize provider for the purposes of fulfilling/delivering the prizes.
