**Simply Sewing issue 142 – Minerva x What Abi Makes – Competition Terms & Conditions**

1. The Promoter is Our Media Limited (company number 05715415) a company incorporated in England and Wales whose registered address is at Eagle House, Colston Avenue, Bristol, BS1 4ST.
2. The promotion is open to UK residents including Channel Islands, to people aged 18 years or older, except the Promoter's employees or contractors and anyone connected with the promotion or their direct family members.
3. The closing date for entries is **11.59pm on 21 January 2026**.
4. By entering the promotion, the participants agree:
  - a. to be bound by these terms and conditions; and
  - b. that should they win the promotion, their name and likeness may be used by the Promoter for pre-arranged promotional purposes.
5. Entrants should enter by entering a multiple-choice question via the competition hosted on Gathered.how. Entries received after the closing date of the promotion will not be considered.
6. Entrants must supply to Our Media Limited their personal data required for us to run competition, choose winners and arrange for prize to be sent to winners – examples would be name and email address. The Promoter will use entrants' personal details in accordance with the Our Media Privacy Policy (<https://policies.ourmedia.co.uk/privacy-policy/>).
7. Only one entry will be permitted per person, regardless of method of entry. Bulk entries made by third parties will not be permitted.
