

### **The World of Cross Stitching issue 369 (March 2026) Emily Joyce Designs competition**

1. The Promoter is Our Media Limited (company number 05715415) a company incorporated in England and Wales whose registered address is at Eagle House, Colston Avenue, Bristol, BS1 4ST.
2. The promotion is open to all residents of mainland UK aged 18 years or older, except the Promoter's employees or contractors and anyone connected with the promotion or their direct family members.
3. The closing date for entries is 23:59 on 24 February 2026.
