

**Terms & Conditions for Regia Premium Prize Draw in The Knitter issue 226**

**LONG FORM**

1. The Promoter is Our Media Limited (company number 05715415) a company incorporated in England and Wales whose registered address is at Eagle House, Colston Avenue, Bristol, BS1 4ST.
2. The promotion is open to all residents of the UK, including the Channel Islands, aged 18 years or older, except the Promoter's employees or contractors and anyone connected with the promotion or their direct family members.
3. The closing date for entries is 11.59pm on 15th April 2026.
4. By entering the promotion, the participants agree:
  - a. to be bound by these terms and conditions; and
